#### Little Sisters of the Poor 2014 Raffle:

The Little Sisters of the Poor Raffle is conducted by the Little Sisters of the Poor of Indianapolis, Inc., a not-for-profit corporation organized under the laws of the State of Indiana. This raffle is licensed by the Indiana State Department of Revenue, Indiana Gaming Commission.

1. The purchase price of a raffle certificate is one ticket for \$100.00 or six tickets for \$500.00. Checks or money orders should be made payable to "Little Sisters of the Poor of Indianapolis." Payment may be made by Visa Bank Card or MasterCard at the Little Sisters of the Poor or by calling (888) 541-7906. Payment can be made online using a bank card or electronic bank draft. If an entrant's check, bankcard, or bank draft is dishonored by the bank, the entry will be declared invalid unless full payment is made prior to the drawing.
2. Completed registration forms must be in the possession of the Little Sisters of the Poor at 2345 West 86th Street, Indianapolis, IN 46260, by 12:00 noon on June 13, 2014, to be eligible for the drawing.
3. Purchasers of raffle certificates must be 18 years or older and must qualify under Indiana law.
4. First prize shall be the winner's choice of a 2014 Chevy Sonic, a 2014 Harley Davidson Road King Classic, \$20,000 in cash, or a dream vacation (value of vacation not to exceed \$20,000 including all taxes and fees. Itinerary and dates to be determined by winner with travel agent chosen by the Little Sisters of the Poor).
5. The names of the winners will be available to the media and a list of winners will be posted at the Little Sisters of the Poor, 2345 West 86th Street, Indianapolis, IN 46260.
6. The raffle will be closed at 12:00 noon on June 13, 2014. Any certificates and money turned in after the closure of the raffle will be returned to the purchaser. All entries will be recorded on a first come, first served basis.
7. Winners will be determined by random drawings. The drawing date will be June 13, 2014, at 4:00 pm at St. Augustine's Home for the Aged, 2345 West 86th Street, Indianapolis, IN 46260. Winners need not be present to win. Winners will be notified by telephone and/or mail.
8. If the first prize winner chooses an automobile, delivery of the first prize automobile will be made to the winner as soon as practicable. However, there may be a delay in delivery because of the availability of the vehicle. If the first prize winner chooses the vacation, travel arrangements will be made as soon as practicable with a travel agent chosen by the Little Sisters of the Poor.
9. Winner will assume and be responsible for all licensing, insurance, registration, transportation and all other fees, and local, state and federal taxes, including without limitation all applicable sales, use, luxury, income and special taxes. 10. If 1,500 certificates are not sold by June 13, 2014, the Little Sisters of the Poor reserve the right to modify the raffle and withdraw the first prize and split the remaining net proceeds (income less expenses) equally between the Little Sisters and the first prize winner. All proceeds, less prizes and expenses, will benefit the Little Sisters of the Poor at St. Augustine's Home.
11. If at least 1,000 certificates are not sold by June 13, 2014, Little Sisters of the Poor at its option may cancel the raffle at any time before the random drawing of certificate winners, and in such event, Little Sisters of the Poor shall return in full to each participant the purchase price of each certificate.
12. More than one name may be stated on an entry form. However, the first listed name shall be deemed the "entrant." The social security number provided must be that of the entrant. Payment or delivery of any prize shall be made solely to the entrant. It is the sole responsibility of the entrant in the multiple party entry to allocate any such prize among the participants in the multiple party entry.
13. Little Sisters of the Poor will hold an early bird bonus prize drawing on May 30, 2014. #### The Little Sisters of the Poor at St. Augustine Home

Since 1873, the Little Sisters of the Poor have cared for thousands of elderly persons with minimal financial resources in central Indiana, regardless of religion or ethnic origin. Today, 8 Little Sisters work with over 100 staff members and hundreds of volunteers to provide a loving home for 96 elderly Residents, in independent living apartments, assisted living units, or in nursing care. The Little Sisters operate St. Augustine as a *true home*, rather than an institution, so that Residents may live in an atmosphere of peace, happiness, and security for their remaining years.

The Little Sisters of the Poor must raise more than half the cost to operate St. Augustine Home each year from donations, and meeting the needs of our Residents is a 7-day-a-week, 52-week-a-year process. In the tradition of our Foundress, St. Jeanne Jugan, we beg for the needs of our elderly Residents and trust daily in God's Providence.

To continue to provide quality care to our Residents, we must raise *\$87 per Resident per day* to supplement government funding, or *more than \$250,000 each month*. Our largest expense is the salaries of the nurses and other staff who so lovingly care for our Residents.

While the Sisters have no fixed source of income and must depend daily on the generosity of others for the funds necessary to manage the home, the atmosphere at St. Augustine Home is calm, warm, and serene. Each Sister, volunteer, employee, and donor contributes time, talent, and treasure out of genuine respect and concern for the elderly.

St. Augustine Home is truly a special place. When one Resident was asked what she liked about living in the home, she exclaimed, "Everything!" She continued, "When you come to live with the Little Sisters, you are not going to an 'old people's home.' You are joining a community... It's like a little family."
