## *The Impact of St. Augustine's Home on Two Generations of a Family*

The devotion of the St. Augustine Guild to the Little Sisters of the Poor has been well-known ever since Guild members helped the Little Sisters move to the new home on 86th Street in 1967. The names of those Guild members litter the rosters of those early years, and the children of those women have fond memories of their parents' involvement and love for St. Augustine's Home and the Little Sisters of the Poor.

Our connection to those early ladies and their children was brought home to one of our current members, Brenda Elmer, during one of her visits to a long-term care facility in Westfield to distribute Holy Communion. One of the residents there asked Brenda what else she was doing that afternoon and she told him she was going out to the Home to work on the gardens. Then he told her that his mother had donated a statue to the Home that had his father's name on it. Sure enough, when she went to the Home and looked at the statue she saw the dedication that resident's mother made to his father and his father's name carved into the stone. Brenda took a picture of the statue and showed it to the resident the following week. The resident shared that his father passed away in 1964 and his mother had donated the statue several years later, which was probably shortly after the new Home was built.

What a precious gift that Guild member gave St. Augustine's Home back in the late 1960's, and what a powerful memory she left for her child to recall, and to share with a current Guild member, some 50 years later.

## **Changes Coming in How You Will Receive the *Gazette***

Beginning with the October 2017 *Gazette*, the following changes will be implemented:

- 1) All Guild members who have an email address will receive the *Gazette* via email. The *Gazette* will be in a pdf format and printable on your personal printer.
- 2) Those Guild members who do not have an email will continue to receive a printed version of the *Gazette* through the mail.

Currently, the annual cost of printing and mailing the *Gazette* is \$1092.48. After this change, the anticipated costs for printing and mailing the *Gazette* to those without email for one business year will be reduced to \$399.40. This is a cost savings of approximately \$693.08 (64%).
